## **Board accomplishments of note:**

- Flu Clinic October 11<sup>th</sup>; Thanks to our partnership with Sobeys Pharmacy in Vernon, and board members who worked the Flu clinic, it once again ran very smoothly. 179 people received their shots. Next year we will schedule visits a bit closer together to allow for more folks to attend.
- Remembrance Day was a very personalized and lovey service and was attended by approximately 105 people.
- Our presentation to the Vernon Jubilee Hospital in November was a proud moment for Desert Cove, our donation amount keeps growing thanks to all of you.
- In December was our annual Christmas Dinner. **180** folks attended Christmas Dinner over two nights. Organizing such a large event was not easy, but as usual, our board members were up to the task. The caterer worked very hard bringing us a great meal and the Cove carolers provided us with festive entertainment.
- In March, the board conducted the DCHAs biannual inventory. This involves cleaning out our storage areas, counting all our assets, disposing of old items, purchasing of new items if required, and updating our asset values.

There are certainly areas where we can improve, however, the good news is that we are in what is considered a green zone (low risk area) and they were impressed that many of our homes already have or are well on there way to FireSmart practices and Xeriscaping.
  - We would, at the very least like fellow Covians to take a look at their "immediate risk zone" and see if there are improvements to be made. We will be sending out some additional information in the near future. We will also be reaching out on behalf of the OKIB to ask for volunteers for the Emergency Support Services Centre (ESS).
- April 20<sup>th</sup> the board hosted a thank you for our volunteers. We decided on breakfast this
  year and treated volunteers to a great breakfast and Brian and Shelly sang a couple of
  songs written just for them. Desert Cove would not be the active community that we are so
  well known for if it wasn't for our volunteers.
